- It is understood and agreed that PL Productions cannot guarantee to produce any video product of any specific object(s), situation(s), person(s), or event(s) or in combination thereof, taken by PL Productions in the performance of the duties and/or services specified in this assignment.
- PL Productions is granted full production and editorial control by The Client with respect to all aspects of the production and post-production services for this event.
- PL Productions has the sole discretion over whether a particular segment of the event is not recorded, partially recorded, or edited from the final product.
- If The Client wishes to delete from the final product an incident or occurrence that transpired at the event, The Client must instruct PL Productions prior to the commencement of editing.
- PL Productions has the right to assign any videographer(s) for this assignment.
- PL Productions must be notified in writing by The Client of any errors within two (2) weeks after delivery of the final product so corrections can be made. Editing errors are corrected at no charge and include but are not limited to spelling, and other technical errors. If The Client fails to provide written notification to PL Productions of any errors within the two (2) weeks after delivery of the final product, The Studio may charge an additional fee for re-editing. Re-editing will be billed at the hourly rate of \$50.00 and will include a duplication fee. The Client agrees to allow PL Productions an additional 10-12 weeks for delivery of the final product if it must be re-edited.
- PL Productions reserves the right to use the original tape and/or reproductions for display, publication or other purposes.
- PL Productions takes utmost care with respect to the exposure, editing, duplication and delivery of the video products and services offered. However, in the event that PL Productions fails to comply with the terms of this contract due to equipment malfunction, fire, act of God, illness, emergency, any event or act outside of the control of the PL Productions, PL Productions' liability is limited to the refund of the deposits.
- Please notify photographer that a videographer will be present.
- It is understood that throughout the entire event, the videographer does not have an opportunity to take an extended break. Therefore, the client agrees to accommodate the videographer and his/her assistant(s) with a meal and non-alcoholic refreshments in the same fashion as the attending guests.
- The date will be reserved with a minimum \$200.00 deposit. PL Productions will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason unless PL Productions is able to fully replace a cancelled reservation, all deposits are nonrefundable, even if the date of the wedding is changed for any reason.
- 2/3 of the package total is due before the wedding date. Balance is due upon delivery of completed DVDs/order.
- PL Productions books a limited number of weddings per year and expects to deliver the final product within 6 months of the event. PL Productions will notify the Client of delays beyond this time.
- \$25.00 will be charged for any returned checks and must be paid before delivery of the DVDs.
